Section 551.087 (1) For the purpose of discussion or deliberation regarding commercial or financial information that the Belton Economic Development Corporation has received from a business prospect that the Belton Economic Development Corporation seeks to have locate, stay, or expand in or near the City of Belton and with which the Belton Economic Development Corporation is conducting economic development negotiations; or (2) to deliberate the offer of a financial or other incentive to a business prospect described by Subdivision (1).*
